Software as a Service (SaaS) vendors, such as Veeva Systems publish regular releases to their hosted applications and the clients must manage these updates on their end according to the vendor's schedule. Although the application upgrade is managed by the SaaS vendor, there is still a significant number of activities within each upgrade that the business and technical teams must perform. Challenges

Clients that implement a new SaaS ECM platform such as Veeva Vault benefit from the advantages of a shared, multitenant platform, but must also address the challenges of such an environment.

- A key advantage of these environments is to be driven and continuously improved based on client feedback and evolving standards. This means that the hosted application environment will be subject to regular release cycles to rollout these enhancements, along with other fixes and patches.
- Many vendors provide these updates several times per year, forcing clients to evaluate the impact of the changes and plan for their implementation every three to four months.
- To assess the impact, clients need to understand what was changed, how the changes will impact their current use, including impact to integrations and interfaces, validation documentation, business processes, standard operating procedures and training.
- A continuous review of the product roadmap in combination with the business process enhancements is essential to ensure alignment between the business vision and the product direction.
- Additionally, "common" post-implementation topics still need to be addressed as well, such as user management, system usage questions, incident, request and change management.
